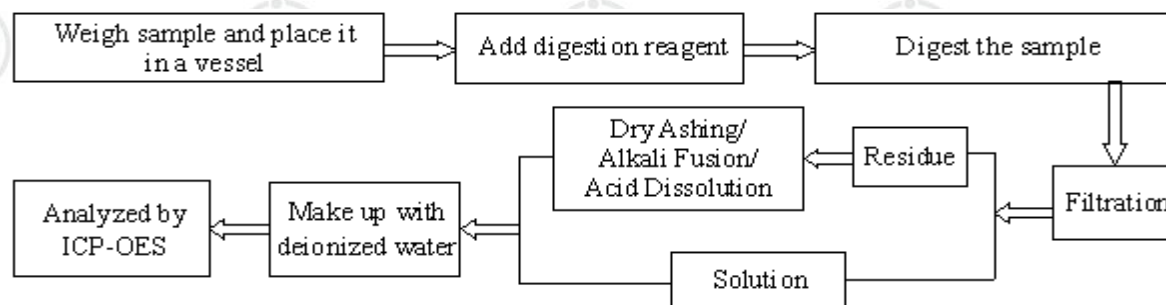

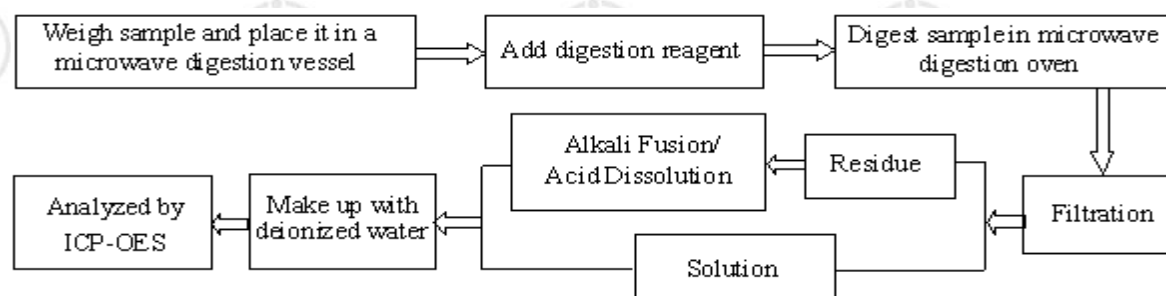

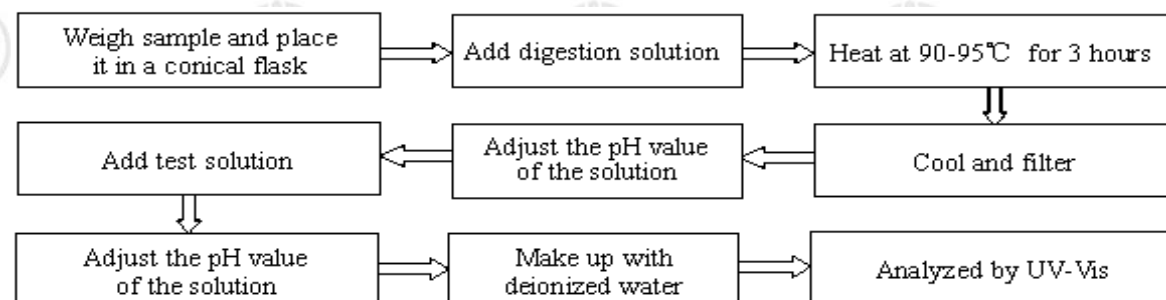
1. Lead (Pb), Cadmium (Cd)



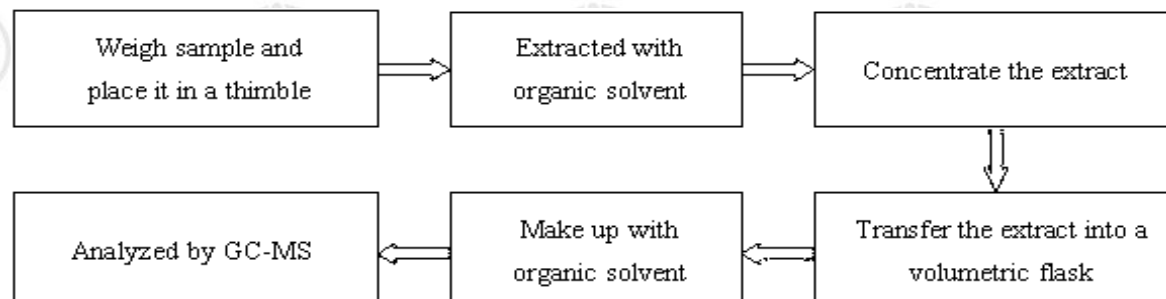
2. Mercury (Hg)

4. Polybrominated Biphenyls(PBBs) , Polybrominated Diphenyl Ethers(PBDEs)

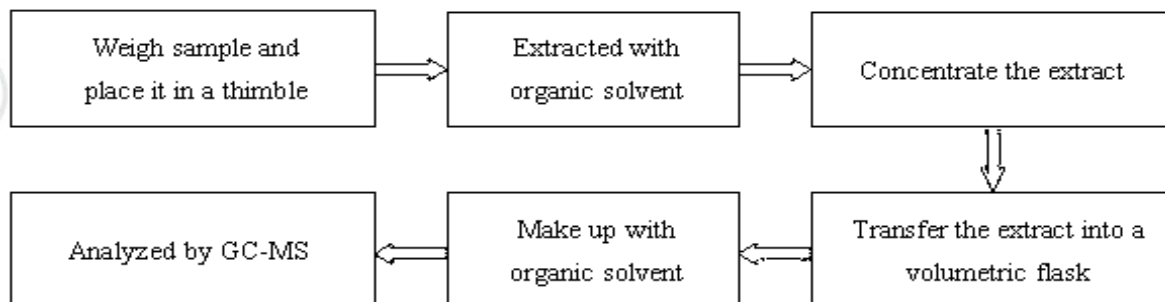
